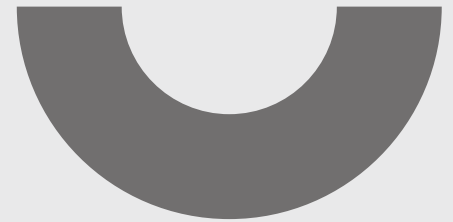

MINIMUM REQUIREMENTS

Minimum Honours Degree in Economics or related. A Master's degree in Economics is a distinct advantage. At least 3 years' experience in an economic or research related environment. Proficiency in Excel is a must. Ability to use pivot tables, SPSS or STATA is a distinct advantage. A valid driver's license.

CORE COMPETENCIES

Economic Research (primary and secondary), Excel calculations; Report writing, Experience in analysis of survey findings; Presentation skills; Independence; Attention to detail. A sense of urgency and positive co-operative behaviour.

RESPONSIBILITIES

Conduct economic research and analysis that influence actionable interventions within the province of KwaZulu-Natal. Proactively identify priority areas that need economic research to be amplified as directed by the provincial government of KwaZulu-Natal. Build up on previous reports to identify areas that need incorporation into a new KZN business intelligence report so that it speaks to the dictates of the provincial government. Submit high-level quality economic advice to the Manager Economics which enables the unit to influence organizational and provincial strategy. Use Excel spreadsheets to manipulate raw data into meaningful economic information. Draw graphs, pie charts, tables, etc. using the manipulated data. Compute average annual growth rates, annual growth rates etc. for input into Business Intelligence Report.
