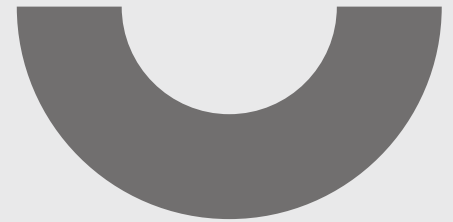

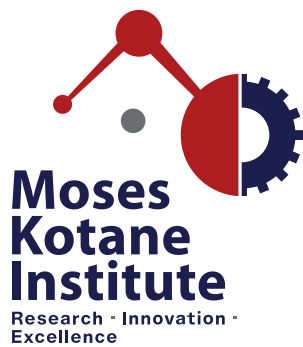

### MINIMUM REQUIREMENTS

A Master's degree in Finance/Economics/ Financial Economics/ Development Studies is a distinct advantage. Knowledge of the KwaZulu-Natal economy's sectors and its material resources. Prior experience in financial services industry, an economics environment and dealing with government entities and departments.
